The Godparents Anthroposophical Training Fund (GATF) was founded in 1968 as the Godparents Association. GATF is a registered charity offering interest free loans and grants for tuition fees to students undertaking designated Anthroposophical vocational training courses in the UK.

GATF also operates the Children's Fund. This fund offers loans and grants for children's tuition fees to assist families in short term financial difficulties to keep their children in Steiner Waldorf education.

## Children's Fund

The Trustees will only consider applications from a Steiner Waldorf School or Kindergarten, who recommend a family for support. Application forms are sent to all qualifying educational establishments in March each year. The Trustees consider the applications in May and funds are paid to the school or kindergarten in September for that academic year.

- ✧ The Trustees will not consider applications direct from parents.
- ✧ Priority is given to those families who have a short term need due to reasons beyond their control such as bereavement.

For the academic year 2008/09 we were able to support 19 families in 13 schools and kindergartens with grants of £22,110.

## Information for students

The Training Fund offers financial assistance to students undertaking the following courses in the UK:


<b>Steiner Waldorf Teacher Training</b>	<b>Rhythmical Massage Therapy</b>

<b>Eurythmy and Eurythmy Therapy</b>	<b>Anthroposophical Speech and Drama</b>

- ✧ Loans are interest free and are given towards **tuition costs** only, for one academic year. Students can apply in February for a further year’s assistance.
- ✧ The Trustees will only consider applications from students who have been accepted on their training course.
- ✧ Students resident in countries outside the European Economic Area (EEA) will be required to hold a visa valid for the duration of the course.
- ✧ Loans are to be repaid within five years of completing the training.

## Information for courses

The Trustees of the Godparents Anthroposophical Training Fund (GATF) rely on training course leaders for assistance in assessing students' suitability for a loan towards **tuition costs** only. The following are the criteria for course eligibility:

- ✘ All courses taking non EEA/EU students must hold a UK Border Agency Sponsor Licence.
- ✘ Teacher Training Courses must be recognised by the Steiner Waldorf Schools Fellowship and comply with the criteria laid down by the Teacher Education Circle.
- ✘ Therapeutic Courses must be recognised by the appropriate body in Dornach.
- ✘ The Trustees will not fund foundation courses, art, music and language courses.
- ✘ The Trustees can only lend to students on viable courses and may ask to see audited accounts.
- ✘ The Trustees will not fund the first year of a course or give retrospective loans.
